What is a community foundation and what does it do?

A *community foundation* is a tax-exempt public charity created and sustained by a community for a community. Governed by a volunteer board of community members who represent diverse interests and managed by professionals with local expertise, the foundation consolidates charitable donations and invests them to generate market earnings. This income, as in the case of endowed funds, can be perpetually distributed to deserving organizations, students, and causes.

How did the Kenosha Community Foundation (KCF) begin?

Nearly a century ago, Kenosha industrialists like Charles C. Brown, H. E. Barden, W. H. Alford, and A. H. Lance had a vision: to pool the charitable resources of community philanthropists into a single, significant, and permanent endowment for the betterment of Kenosha. That vision led to the formation,

in 1926, of one of the country's earliest community foundations.

A Note From KCF Leadership

Because of the generosity and tireless efforts of so many fund advisors, our Board of Directors, volunteers and staff, KCF is standing ready in 2025 to grow our mission and grow our impact.

In this 2024 Report to the Community, we will highlight key organizational achievements that include:

Fundraising Campaign Success: Our 2024 balance sheet shows a historic level of assets under management (17M) and five new endowed component funds were established. Together with a committed campaign committee, we realized the objective on behalf of the Kenosha County Ceremonial Courtroom Restoration Project, achieving the goal of raising 1.45M in each and plodges while securing an additional 775K in

Incorporating Visionary Leadership: We welcomed Jodi Keene as our Accounting Specialist, while our newest Board member, Adam Mannetter made an outsized contribution. We saw transitions across our Board and committee members to include new faces and leadership perspectives.

Realizing Strategy: We made significant strides in all three functional areas of our strategic plan; community engagement, cultivating philanthropy and internal capacity building. Grant support advanced three priority areas of sustainable communities; workforce development, health and human services and the natural environment.

Impacting Community Through Grants and Scholarships: Our team moved all scholarship and grant application forms online while working in closer alignment with school districts across the county to receive/process a historic number of scholarship applications and a record number of grant applications through competitive cycles.

Our mission, after nearly 100 years remains vital, stewarding lasting philanthropy across individuals and organizations to enable health and development across the greater Kenosha area. Work with us in new and valued ways to leave this place—and yourself—forever transformed!

In 2024, a new designated fund was established to support the Kenosha Symphony Orchestra (KSO) in the name of Grace Kolakowski. Grace's family identified a shared passion for the performing arts, so they established a permanent endowment to ensure support for the annual KSO concert series. Together they envision working collaboratively with the Kenosha Unified School District to involve high school students into KSO performances, while broadening the appeal and appreciation for symphonic music. Grace's hope is that like-minded music lovers will follow her lead and make additional contributions to the fund so that the KSO continues to enrich the Kenosha community for generations to come.

KVNA Legacy Fund for Community Health

Launching its first competitive grant cycle in 2024, the Kenosha Visiting Nurse Association (KVNA) Legacy Fund for Community Health awarded three grants to partners advancing health among communities of seniors and those with disabilities, namely, individuals that are homebound. As a grant recipient of this new fund, the Kenosha Area Family Aging Services, Inc (KAFASI) will apply these funds to strengthen the 'Meals on Wheels' Program, leveraging thousands of volunteer hours annually and connecting directly with a too-often unseen community. The 'Meals on Wheels' Program enables the elderly, the sick, and the disabled to remain in their own homes with help from people who care.



Major Project Milestone

KCF is thrilled to announce that a 3-year fundraising campaign in partnership with Kenosha County, raising funds for the restoration of the Ceremonial Courtroom, has proven successful. Serving as the fiscal sponsor and a member of the committee, in June 2024 KCF reported meeting the challenge of the Jeffris Family Foundation. The campaign committee completed Phase 2 to match an additional challenge grant from the TAWANI Foundation founded by Col. Jennifer Pritzker, who established the Pritzker Military Museum & Library located in Kenosha County. Thank you to all supporters of this ambitious project set to open to the public in 2026.

Our **Goals** are to: **Engage the community** through meaningful relationships, open communication, and inclusive initiatives.



At the heart of our transformative journey was a re-envisioned branding process, seamlessly integrated with the ethos of the Kenosha Community Foundation. This strategic initiative not only focused on engaging external stakeholders but also harnessed the power of a unified brand identity.

We worked with Vendi Advertising to align our messaging effectively by honoring the Foundation's rich history, symbolized by the enduring pillar in its logo, while embracing its forward-thinking, ever-growing, and evolving nature represented by the reaching leaf. This holistic approach exemplifies our dedication to creating a positive, lasting impact on the communities we serve.



Initiatives / Opportunities Workforce Development

Kenosha County's 2022 "Moving the Needle?" analysis of annual worker pay rates indicates significant structural challenges in the economic and social sectors. The county's wages are consistently lower than those in the 11 peer communities/counties, and there are pronounced racial disparities in median household incomes. Given these challenges, investing in preparation for work and career readiness is crucial. Strategically directing funds towards scholarships and grants for nonprofits can equip more working-age adults to meet current workforce demands, fostering a higher quality of life in healthy home environments.

Between the start of 2022 through the end of 2023, the Kenosha Community Foundation (KCF) awarded more than 50 higher education scholarships (undergraduate and graduate level). KCF awards nearly \$90,000 annually in scholarships to deserving students. The Foundation works closely with scholarship fund advisors to make serious considerations in designing criteria that incentivize student applications to regional or Kenosha County-based schools, namely Carthage College, Gateway Technical College, and the University of Wisconsin Parkside. With excellent choices in higher education nearby and a growing local employer base, KCF seeks to ensure that viable, affordable, and manageable pathways exist for local talent to train and study in the area or return to this community after graduation as future leaders and mentors.

The KCF targets underserved audiences through grants to nonprofits supporting workforce development in our community. Funded projects include skill development, occupational placements, employer recruitment/ engagement efforts by Shepherd's College for those with developmental disabilities, and tutoring in reading, math, and social-emotional learning through Kenosha's YMCA. Junior Achievement focuses on entrepreneurship training for young adults, while minority business owners receive support through grants to Wisconsin Women's Business Initiative, Corp.

In 2023, KCF collaborated with a longstanding donor/fund advisor to explore opportunities for increased financial resources dedicated to fostering employment success. Through direct services from two Kenosha County based nonprofit organizations, KCF initiated a pilot program, funding support services for five individuals with incarceration records and facing significant employment barriers. Key insights from the pilot emphasized the need for more direct employer engagement. This may lead to the creation of Workforce Development Pilot 2.0, directly geared toward employers headquartered in Kenosha County.

Workforce development remains a critical yet promising area for investment by KCF and its many partners. This investment aims to ensure the competitiveness of the region, with a focus on meaningfully addressing economic barriers.

Initiatives / Opportunities Health & Human Services

In alignment with the 2023 Kenosha County Community Health Improvement Plan (CHIP), local healthcare agencies, collaborating with at-risk community members and various partnerships, have identified a critical need to enhance health outcomes by addressing healthcare access.

A primary strategy to achieve improved healthcare access and outcomes involves ensuring an ample presence of healthcare professionals within the community, thereby minimizing patient waiting times and ensuring culturally relevant care. The Kenosha Community Foundation (KCF) actively contributes to this strategy by providing three scholarships, two at the undergraduate level and one at the master's level. Specifically, the Colombe scholarship supports Gateway Technical College students pursuing nursing, the Clay Davison scholarship is geared towards students pursuing mental health professions, and the Martha Hollowell scholarship is directed at master-level study in mental health fields.

The second key strategy outlined in the CHIP report focuses on reducing the stigma surrounding mental illness and substance abuse. KCF addresses this objective by funding various projects that foster family and community connectedness. Initiatives include the establishment of a youth-focused LGBTQ task force, the creation of a "safe space" and library facilitated by Congregations United to Serve Humanity (CUSH), and a family engagement and cultural awareness project aimed at diminishing the risk of gang involvement (Kenosha Boys and Girls Club). Additionally, KCF supports programs like Peace Learning Circles, emphasizing positive relationships, communication, and conflict resolution, directly impacting different generations and aligning with the goals outlined in the CHIP report.

Recognizing the pivotal role of food access in health outcomes, KCF has championed several initiatives addressing immediate needs. Noteworthy contributions include funding of the Kenosha Food Bank for the holiday meal box project to combat food insecurity through culturally-relevant and nutritious contents. Moreover, KCF supports a senior nutrition program that ensures access to healthy meals and provides spaces for community bonding, contributing significantly to the overall health and well-being of the aging population through collaboration with Kenosha Area Family and Aging Services, Inc.

"With the senior population rapidly growing, surpassing millennials in five years, accessing nutritious food is challenging, especially for those near poverty. Skyrocketing costs force seniors to choose between food and medication. Senior Nutrition programs address health changes, offering tailored meals for conditions like diabetes and cancer. Beyond sustenance, these programs combat loneliness, reducing depression. The Kenosha Community Foundation's support is instrumental in providing quality services, paving the way for future collaborations, such as Food Pharmacies, and innovative approaches for healthy aging."

Initiatives / Opportunities Natural Environment

Our communities stand at a crucial juncture, contemplating the intersection of science and decisive action in the face of escalating climate-related challenges. The 2021 peer-reviewed report, meticulously prepared by The Wisconsin Initiative on Climate Change Impacts (WICCI) titled "Wisconsin's Changing Climate: Impacts and Solutions for a Warmer Climate" presents local temperature data that demonstrates the past two decades have been the hottest on record. Likewise, the last decade marked the state's record for precipitation. The consequences of these climatic shifts are evident in the intensification of weather events across virtually every region of Wisconsin, providing a sobering preview of the challenges ahead. Even within the local context, Kenosha County communities are vulnerable to the relentless impacts of persistent heat, flooding, and shoreline degradation.

The Kenosha Community Foundation (KCF) is listening, advocating, and fully engaging in this work as it actively supports those responding to recommendations found in the WICCI report: avoiding grassland or natural vegetation conversion to row-crop production or urban development, maintaining forest cover and urban tree canopies with the most significant potential to store carbon, prioritizing habitat management actions that provide food, and investing in flood risk reduction practices.

In 2023, the KCF became acquainted with the Kenosha County Regenerative Producers Group (KCRPG), a farmer-led initiative to support interested local landowners' conversions toward more sustainable agriculture practices. Upon realizing that the volunteer leadership of KCRPG was considering nonprofit incorporation but felt it would be too difficult and premature to do so, the foundation encouraged their leadership to consider an alternative partnership. Together, these conversations led to the decision to affiliate with an existing peer nonprofit already actively working in environmental sustainability, RootPike-WIN, so that KCRPG could seek financial support. The Palmer Foundation became involved through the network of KCF donors. They provided backing for KCRPG to cover costs for a crops and soils consultant to actively instruct farmers on conservation strategies that would be cost-effective and suited to the unique composition of their acreage.

Beyond developing partnerships and extending Foundation resources to those across a network, the KCF issued grant awards to buffer restoration efforts in the City of Kenosha's Lincoln Park Lagoon via RootPike-WIN. Likewise, by reaching audiences through museum learning experiences, the KCF supported Kenosha Public Museum's National Geographic's "Planet or Plastic?" exhibition that explored the impact of plastic pollution in waterways.

"Please realize that over 40% of the land in Kenosha County is controlled by farmers, while farmers make up less than 1% of the population. Since this is by far the county's most extensive land usage, it dramatically impacts Kenosha's environment and the water quality of the community. Our goals at Kenosha Regenerative Producers Group are to strike a balance by using farming practices that safeguard our natural resources while growing local food for Kenoshans and increasing farmer profitability. This can only happen through collaboration.
The Kenosha Community Foundation, with its strong roots in Kenosha, helps connect the many participants needed for collaboration to build this important network.
